



# Privacy Policy

Privacy policy for robybar.it Web Site of the society Roby Bar SNC (art. 13 D.lgs. 196/03)

In this page we describe the modalities for this site to manage personal data collected about the user, in order to respect the privacy law – art. 13 D.lgs n° 196/2006 – and the General Data Protection Regulation (GDPR) (EU) 2016/679.

By visiting the web site, the methods described in this Privacy Notice are implicitly accepted. The policy is only valid for the site robybar.it and not for other external sites, accessible via links.

## Ownership of Personal Data Handling

Roby Bar SNC di Caterina Egidio & Siervo has the ownership of personal data handling; the address of the company is piazza Garibaldi 4, 28068 Romentino NO (Italy).

## Place of Personal Data Handling

Data management connected to services of robybar.it happens in the location of Romentino - see the address in the previous point - (and on the remote server of the site). None of the collected data is shared with other organizations or agencies. Personal data provided by users, sending requests for information through the contact section, are used to perform the requested service.

## Type of Data Management

The site is almost entirely navigable without having to communicate any personal data.

### **Personal information, voluntarily shared by the user**

Personal information (name, e-mail address and telephone number) are required only in Contact section. This information is used for the required services; in particular for answering specific requests for information, availability and for reservations by the user.

### **Navigation data**

The computer systems and the software of this website use, during their normal operation, personal data whose transmission is implied in the execution of Internet communication protocols. These information are not collected to be associated with an identified user, but for their kind they could allow to identify people, through elaborations and associations with data held by third parties. This category of data includes the IP addresses or domain names of the computers used by the users that connect to the site, the URI addresses of the required resources, access times and other technical parameters related to navigation, operating system and computer environment of the user. This data are used only for the purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing.

## Data Holding Processing

Personal data are handled with automated tools for the time necessary to achieve the purposes for which they were collected, by providing the required information.

In any case, for the contact section the retention period will not exceed the 10 year threshold. This limit has been chosen because the name, e-mail address and telephone number could be used for communications containing commercial/tax data. For example, for a customer asking us for information about a reservation. Currently the legislation imposing the conservation for 10 years of legal and commercial emails according to articles 2214 of the Civil Code and 22 of DPR 600/1973.

## Rights of the parties involved

All the users of the site have the right to obtain confirmation of the existence of their personal data in our information systems, to verify their accuracy or to request their integration or updating or rectification.
